In compliance of the order dated 20.09.2016 of Hon'ble Supreme Court of India in Writ Petition (Civil) no. 652 of 2016 in the matter of Subhash Kumar & ANR V/s UOI & ORS the vacant 15% All India Quota Under Graduate (MBBS/BDS) seats shall not be transferred to States till further order. Accordingly State authorities are advised not to fill up 15% All India Quota vacant seats of Round 2 till further orders.
