UPON hearing the counsel the Court made the following
ORDER

It is submitted by Mr. P.S. Patwalia, learned Additional Solicitor General appearing for the State of M.P. that 91 seats (MBBS-87, BDS-4) in the government colleges are lying vacant.

Patwalia, learned Having heard Mr. Solicitor General for the State of M.P., Ms. Pinky Anand, learned Additional Solicitor General for Union of India, Mr. Gaurav Sharma, learned counsel for the Medical Council of India and Mr. Vivek Tankha, learned senior counsel along with Mr. A.P. Shroti, learned counsel for the A.P.D.M.C., it is directed that the 91 seats which are within the government quota shall be filled up by the State of M.P. As far as the other seats are concerned which are lying vacant in private colleges, they shall be filled up by the State in terms of the order passed by the Constitution Bench without insisting on domicile. It is hereby made clear that the students who have already taken admission, their admissions shall not be disturbed.

The State of M.P. shall file an affidavit of the competent authority indicating the names of the students, who will be taking admission from today in respect of government colleges as well as the private colleges indicating their qualifications. This exercise shall be completed on or before 7th October, 2016. If any admission is given after

that date, it shall be deemed to be an invalid admission. The seats which are falling in the BDS stream shall also be filled up by following the same criteria.

The interlocutory applications relating to the State of M.P. stand disposed of.

Ms. Pinky Anand, learned Additional Solicitor General appearing for the Union of India has filed a chart which is not complete. She will file a complete chart by 5th October, 2016.

The other interlocutory applications as well as the other matters relating to the other States shall be listed on $6^{\rm th}$ October, 2016.

It is hereby directed that the seats which are reverted to the State quota and remain unfilled, shall not be filled up till then.
