- 1- These rules may be called " M.P. Medical Superspeciality Course (DM/MCh.) Entrance Examination and Admission Rules, 2014 for admission in Government Autonomous Medical Colleges & State Government Quota Seats in Private Medical Colleges of Madhya Pradesh.
- 2- **Courses, Institutions & Seats.**

3- Eligibility

Requirement for admission to Super-Speciality (D.M./M.Ch.) Courses :-

- 3.1 The candidate must be Citizen of India.
- 3.2 The candidate must have passed the Postgraduation (MD/MS/DNB) in the relevant subject on or before 31 August, 2014.
- 3.3 The candidate must have registration of M.D./M.S./DNB with Medical Council of India/State Medical Council.
- 3.4 The candidate holding DNB will be eligible for admission to superspeciality courses, provided they have done thesis work, evidence of thesis shall be produced by the candidate.



3.5 The candidate can apply for one or more courses as per their eligibility and give their preference choices for the course and institution. (If available)

3.6 A candidate who has already acquired a superspeciality degree in any one discipline is not eligible to apply for any other discipline.

3.7 A candidate who is presently undergoing superspeciality course elsewhere in any one discipline is not eligible to apply.

3.8 Eligibility qualifications for different courses shall be as given below in the Table :-

4- Duration of Course

The duration of superspeciality course shall be of three completed years including the period of examination.

5- The superspeciality (DM/M.Ch.) courses are full time courses. No candidate shall be allowed to do private practice apply for/ to join any other course/ any post, once he/she has been admitted in a course till the course is completed.

6- Procedure for submission of application form and Fees



6.1 Duly completed Application shall be submitted in Directorate of Medical Education, 6th floor, Satpura Bhawan, Bhopal by post/personal submission upto **15 September, 2014 5.00 P.M.** Applications received after last date and time will not be considered. (Annexure-I)

6.2 Demand draft in favour of Director of Medical Education, Payable at Bhopal amounting Rupees 5000/- should be enclosed along with the application form.

7. Entrance Examination.

7.1 There shall be a written Entrance Examination for all DM/M.Ch. courses to be held **On 22nd September, 2014 Monday, 11.00 A.M. to 1.00 P.M. at Gandhi Medical College, Bhopal.** Admit card for the entrance examination will be issued to all eligible candidates before commencement of examination at the examination centre **Gandhi Medical College, Bhopal.** It is advisable that all candidates reach the examination centre **Gandhi Medical College, Bhopal,** one hour before commencement of examination.

A candidate in order to become eligible for counselling and seat allotment must obtain minimum 50% marks in written entrance Examination.

8. Mode of Entrance Examination :

8.1 There shall be one paper of 100 marks of two hours duration.

8.2 The paper will be of Multiple Choice Questions (MCQ) type, each question having one correct answer.

8.3 There shall be no negative marking.



8.4 There shall be no mark awarded for more than one answers in one MCQ type question.

9. **Declaration of Results.**

Merit list will be prepared of all eligible candidates on the basis of marks obtained in written Entrance Examination.

9.1 In case, two or more candidates obtain equal marks, the inter-se-merit of each candidate shall be determined in order of preference as follows :-

- (i) The candidate who has passed the qualifying examination (MD/MS/DNB) in the first/less number of attempts will be given preference for admission.
- (ii) If the number of attempts in MD/MS/DNB are same then the candidate who has got more aggregate marks, (taking into consideration marks of all the three professional examination of MBBS course to-gether) will be given preference for admission.
- (iii) If the candidate are equally placed after 9.1 (i) & 9.1 (ii) then, the candidate older/Oldest in age will be given preference for admission.
- (iv) The merit list will be displayed on the notice board of Directorate of Medical Education, 6th floor, Satpura Bhawan, Bhopal on 23th September, 2014.

9.2 The verification and scrutiny of Original documents & counselling will be held in the **Directorate of Medical Education, 6th floor, Satpura Bhawan, Bhopal on 23 September, 2014 from 11.00 A.M. onwards.**

9.3 The seat allotment will be made strictly on merit cum choice basis.

9.4 The final result after counselling shall be notified On **23rd September, 2014.**



10- **Procedure for admission and payment of fees.**

- 10.1 The candidates who have been allotted a seat shall have to take admission on the allotted DM/M.Ch. course on **26th September, 2014 between 11.00 A.M. till 5.00 P.M.** in Directorate of Medical Education, 6th floor, Satpura Bhawan, Bhopal and shall deposit the prescribed fees & Original documents at the time of admission. The fee details of the Private College are available on AFRC Madhya Pradesh website.

Those who fail to do so will lose their claim for admission to the allotted course and their allotment shall be treated as automatically cancelled. The seat remaining vacant will be allotted to other candidates in the merit list on 29th September, 2014 and such candidate has to take admission in allotted course/college in Directorate of Medical Education, 6th floor, Satpura Bhawan, Bhopal by depositing the prescribed fees & Original documents on the same day i.e. 29th September, 2014 between 11.00 A.M. till 5.00 P.M.

- 10.2 The candidate will have to produce the following original documents at the time of Scrutiny during the Counselling and at the time of admission :-



11- **Seat Leaving Bond.**

After taking admission on the State Quota allotted seat (Govt./Private) candidate has to submit an affidavit stating that he/she will complete the course and will submit a seat leaving bond in the prescribed format stating that if he/she resigns on the seat due to any reason on the date of commencement of last round of counselling or thereafter and before the completion of the course, he/she will have to deposit Rs. 10.00 lakhs (Rs. Ten lakhs) to the Autonomous Society of concerned Govt. College; and to the Director of Medical Education, M.P. Bhopal in case of Private unaided Medical College as financial penalty. Or else it will be recovered as land revenue arrear. Only after that original documents will be returned to the candidate.

12. Any modification or clarification of the above rules and any further instruction to the candidates will be posted in the Director Medical Education Bhopal website www.medicaleducation.mp.gov.in. Therefore it is advise that the candidates should check the above mentioned website on regular basis.
13. The State Government reserves rights to make any further amendment to rules if required.
